Non-equestrians occupying Horse camping sites

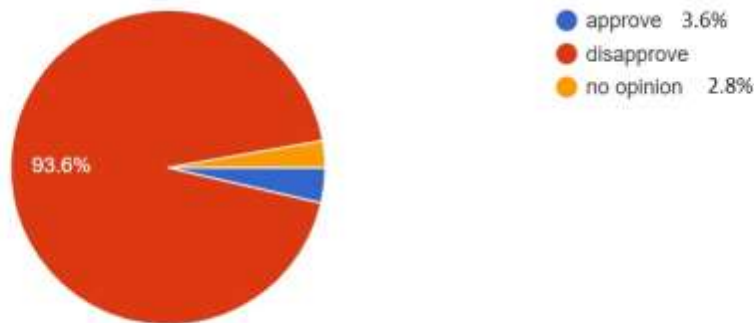

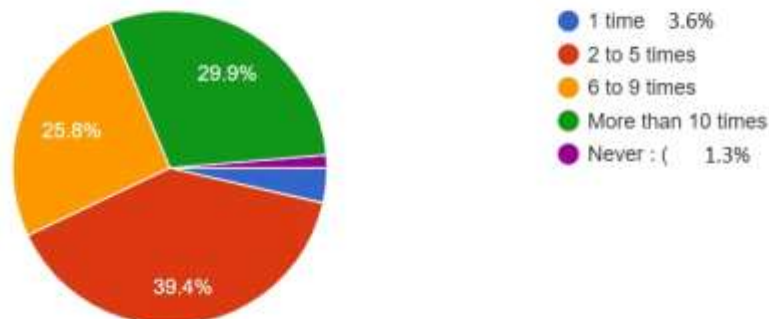
1. Do you approve, disapprove or have no opinion concerning Non-equestrians occupying Horse camping sites?

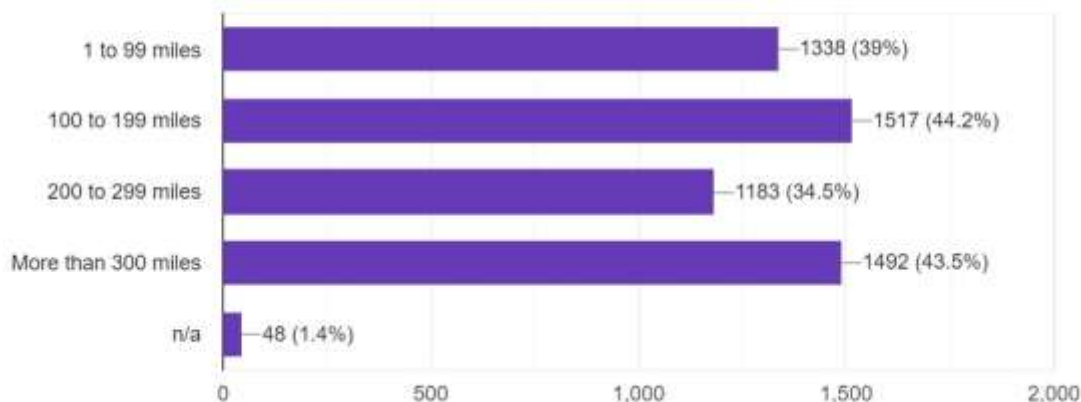
2. How many times do you visit a Horse camping site in a year?

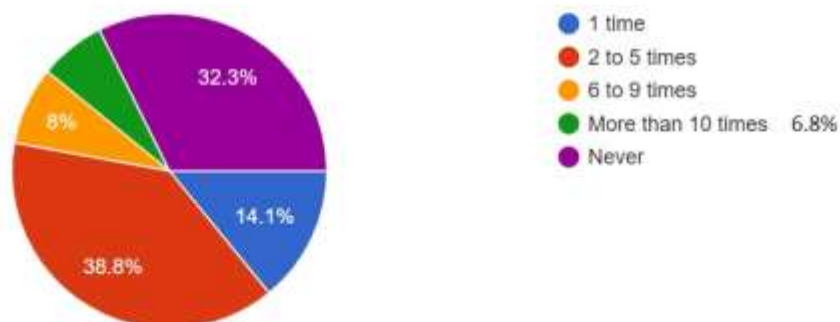
3. How far have you driven to camp with your equines at a Horse camping site? Pick all that pertain.

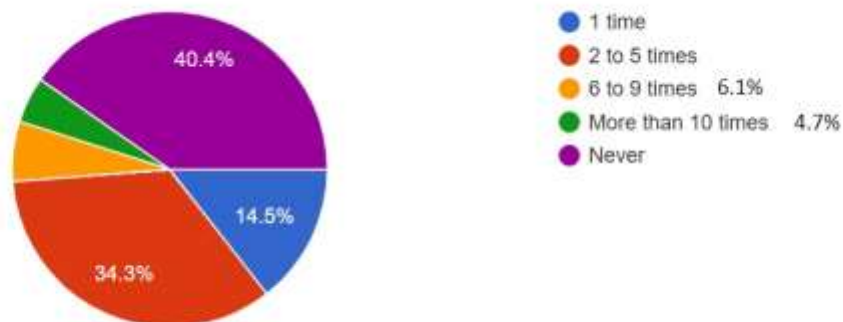

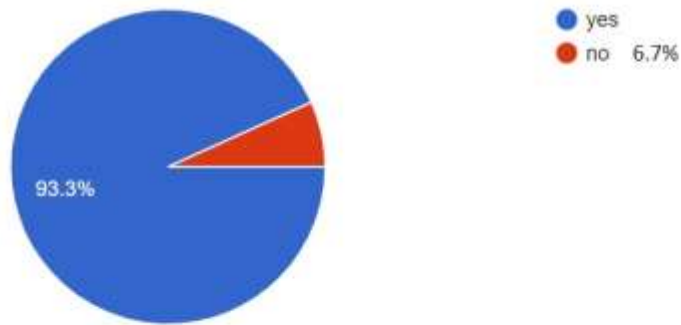

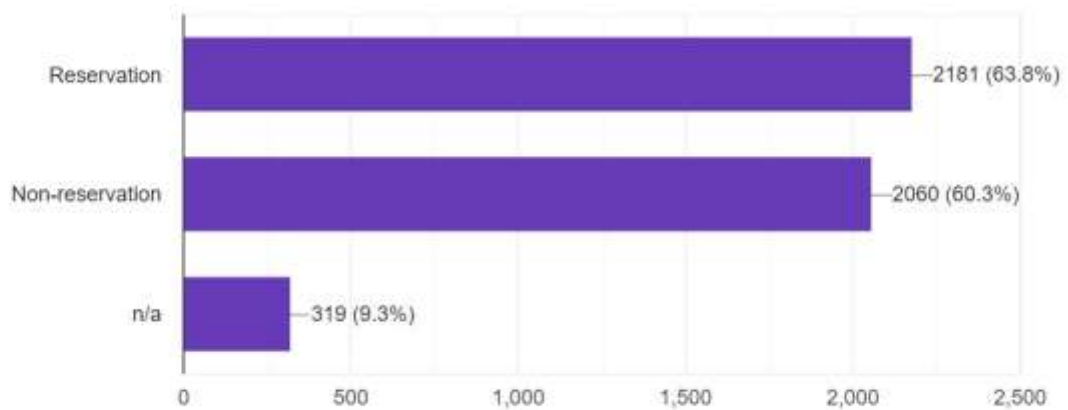
6. Have you ever observed Non-equestrians occupying a Horse camping site?

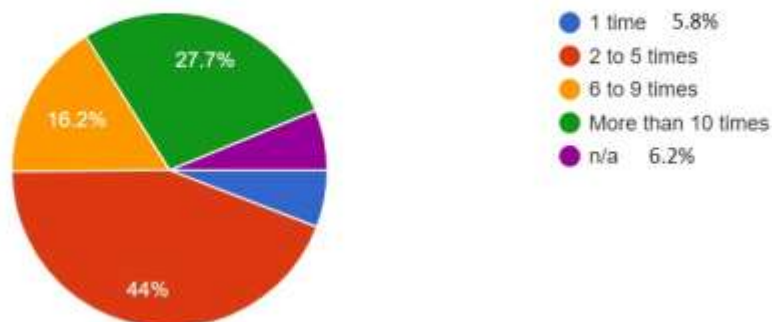
7. Did this happen in a Reservation or Non-reservation Horse camping site? Pick all that pertain.

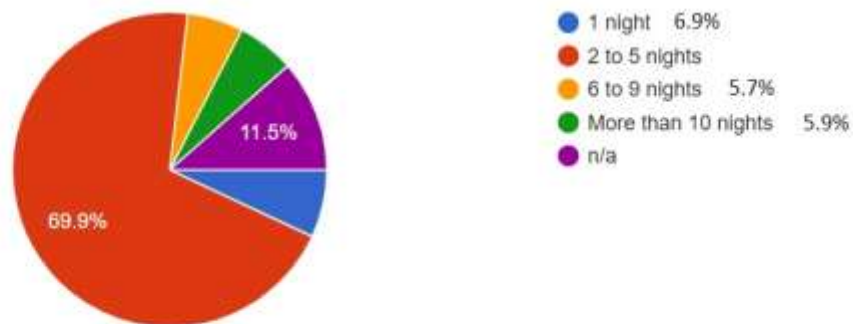
8. How many times have you observed Non-equestrians occupying a Horse camping site?

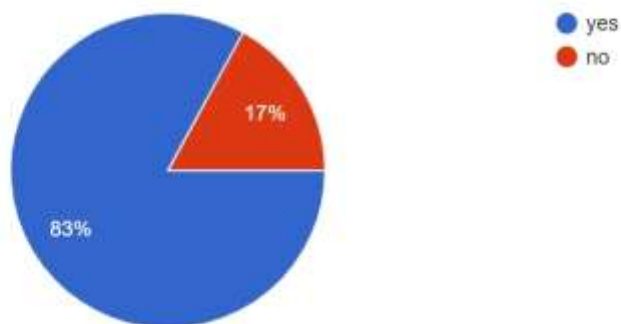
9. How many Nights did you see Non-equestrians occupy the Horse camping site in a row?

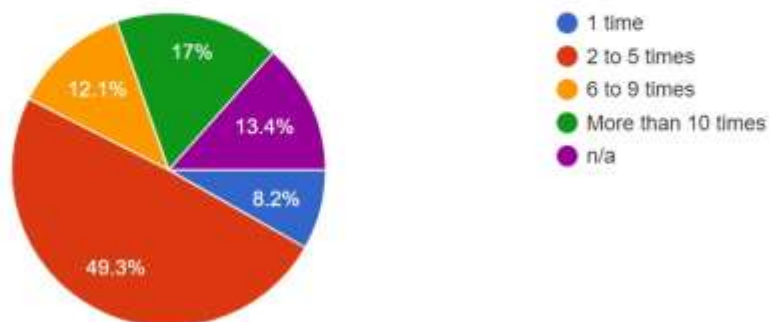
10. Have you observed more than one Horse camping site being occupied by Non-equestrians?

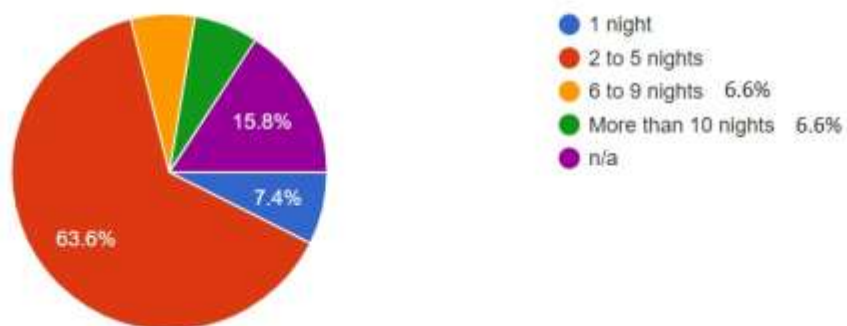
11. How many times have you observed more than one Horse camping sites being occupied by Non-equestrians?

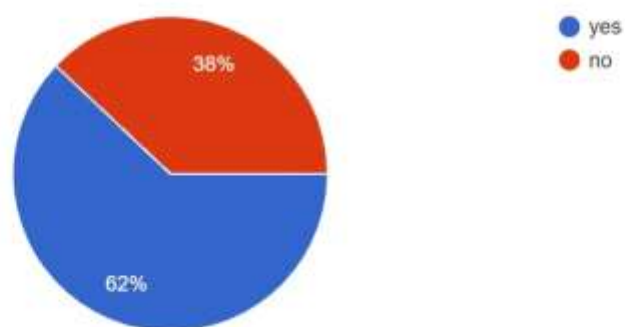
12. How many Nights did you see more than one Horse camping sites occupied by Non-equestrians in a row?

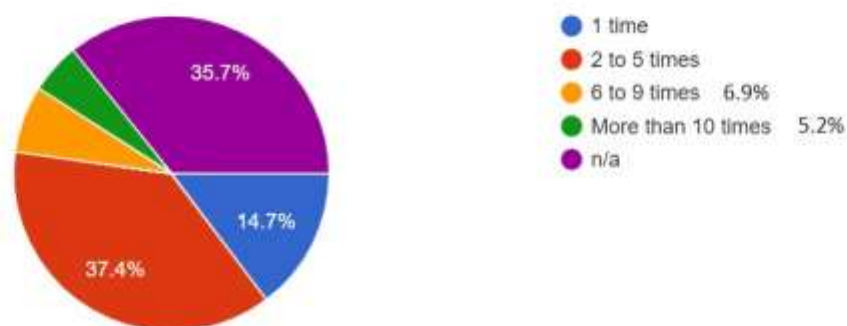
13. Have you ever arrived at a Non-reservation Horse camping site, only to find nowhere to camp because sites were occupied by Non-equestrians?

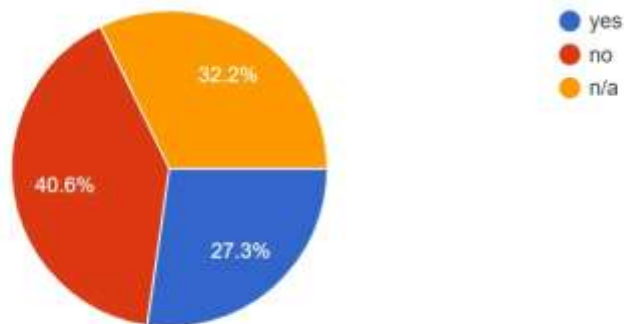
14. How many times have you arrived at a Non-reservation Horse camping site only to find nowhere to camp because sites were occupied by Non-equestrians?

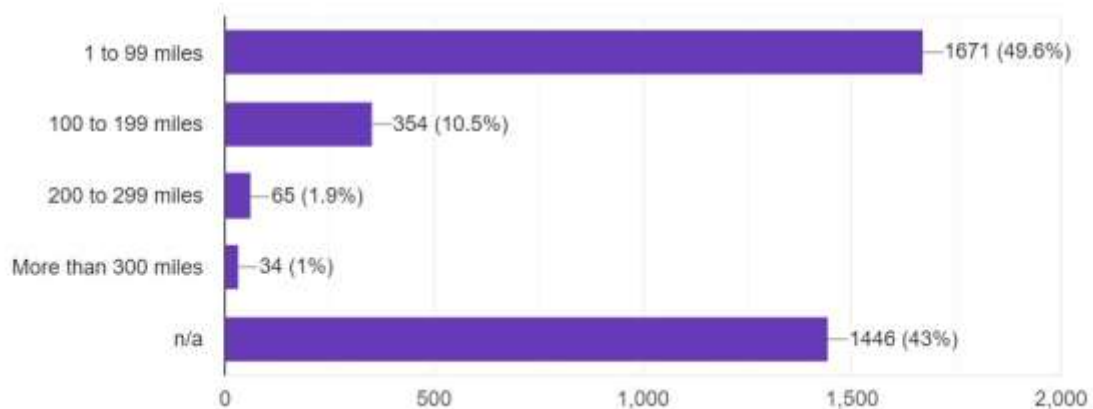
15. Were you able to find another place to camp with your equines when the Non-reservation Horse camping sites were full due to them being occupied by Non-equestrians?

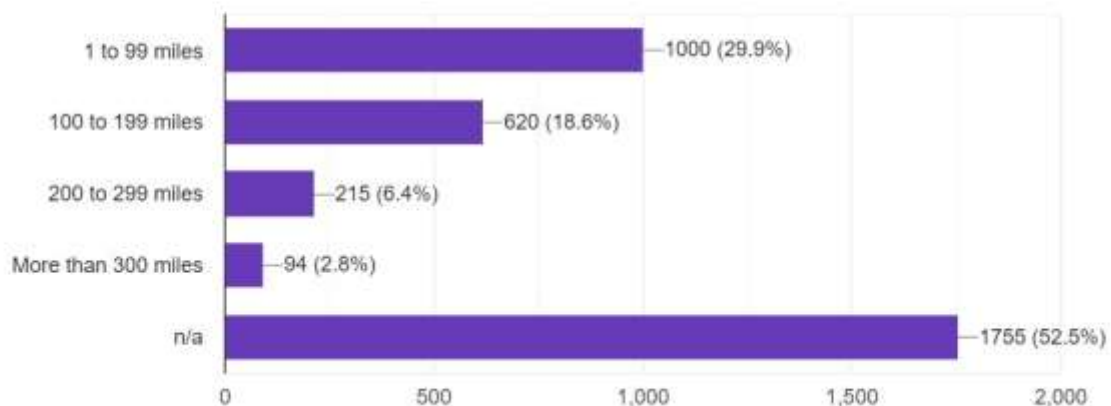

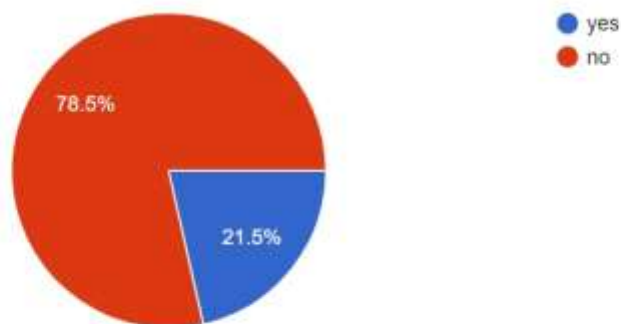

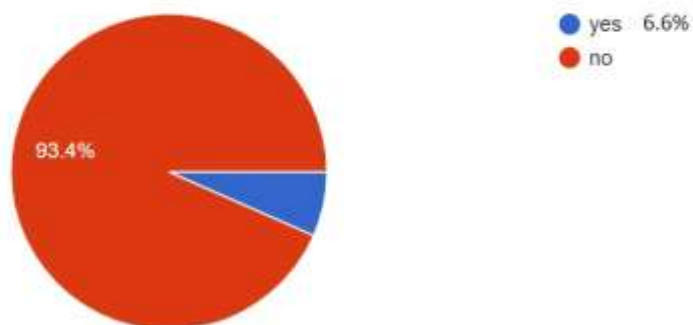
18. Have you ever asked a Non-equestrian camper to vacate a Horse camping site they were occupying for you and your equines?

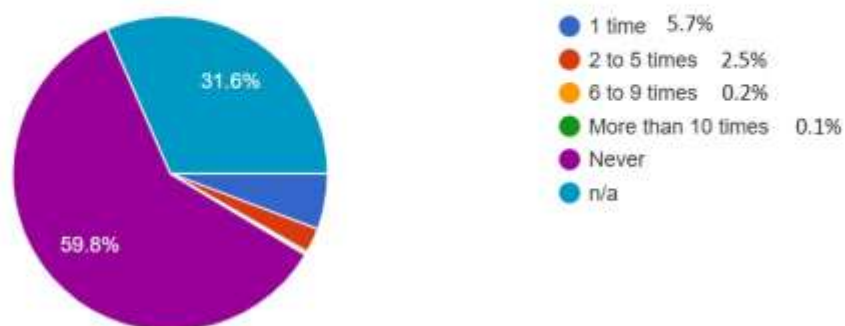
19. Have Non-equestrian campers ever vacated a Horse camping site they were occupying for you and your equines?

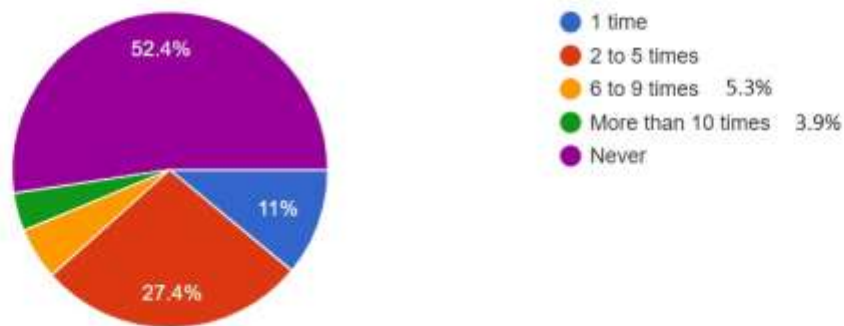
20. How many times have Non-equestrians vacated a Horse camping site for you and your equines?

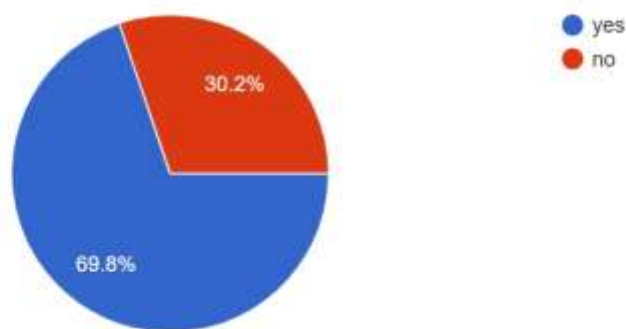
21. How many times have you canceled a Horse camping trip because you feared there wouldn't be a Horse camping site available to you when you arrived due to Non-equestrians?

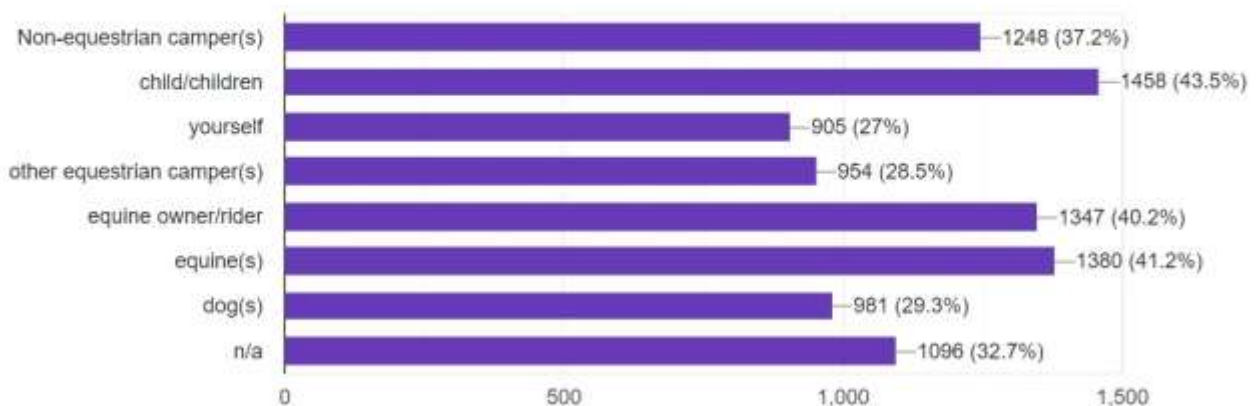
22. Have you ever seen, or had Non-equestrians, inadvertently or otherwise, cause a potentially dangerous situation in the Horse camping area that you were staying in?

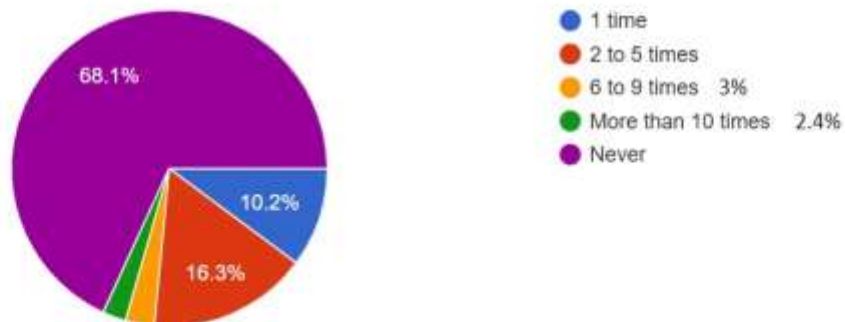
23. Who was injured, or at risk of injury, in the situation you saw happen, or were involved in? Pick all that pertain.
